Our Strategy

Saved by Grace Medical and Education Foundation is a non-profit organisation with a God-given vision which is to **improve the lives of people in Nigeria**.

To meet the vision, the organisation has the mission to provide financial assistance to indigent persons for medical and educational purposes.

It is important to the charity to be **accountable to all our stakeholders**. We have built this strategy so that we can be held accountable by the world on how we meet the vision and the mission of the charity.

Mission Breakdown

Our Mission can be split into three sections;

1. To provide financial assistance to meet the **educational needs of persons in primary school within Lagos State**.
2. To provide financial assistance to meet **maternity related medical needs within Lagos State**.
3. To perform sensitization events to **educate persons about their health in Nigeria**.

How we plan to meet the needs?

Funds received on behalf of the foundation will be used to meet the above listed mission.

Each case will be discussed by the Trustees before any assistance is rendered. In situations where donee has received funds from the charity before all Trustees have been informed; a formal disclosure must be made in the board meetings.

Before funds are released to the donee of the foundation, certain criteria need to be met. Criterions will differ based on the above listed mission (See criteria below).

Evidence will be gathered on a case-by-case basis and be saved to the drive of the charity with the name of the donee.

All funds will be paid to the account of the organisation.

Criteria for Education needs

Educational needs can rise from different situations and depending on this, the trustees of the charity will determine what criteria are applicable before funds are released.

Evidence that may be required will include:

- Employment letter and Termination letter.
- Death certificate of caretakers/guardians
- Letter must be written to the charity for assistance

- Information given in letter written to charity must be guaranteed by religious leader or non-family member who can vouch for the donee.

Additional clause: The charity would determine the extent of help to be provided and every case would be re-evaluated as needed.

Criteria for Medical needs

Medical needs to be covered by the charity are currently restricted to needs that arise due to pregnancy and delivery.

Evidence that may be required will include:

- Letter must be written to the charity for assistance
- Bill from the hospital

Additional clause: The charity would determine the extent of help to be provided and every case would be re-evaluated as needed.

Sensitization Events

All sensitization event will be discussed by the trustees and documented in the meeting minutes by the secretary. All expenses made towards the event will be filed and saved on the Charity's drive using the purpose, location and date of the event.

All events will also be disclosed in our annual report and a detailed report on the event will be kept in the Charity's drive.
